ATTENDANCE INFORMATION

After a couple of requests, I would like to clarify the procedures around attendance, unauthorised absence and Local Authority penalty notices.

Firstly, we are obliged by law to monitor your child's attendance carefully. This means we will let you know if your child's attendance is less than (or approaching) 90%, as this is the threshold the government uses to classify as the child being a 'persistent absentee'. Please do not be offended if you have received a letter about this, even though your child's absence includes a term-time holiday or illness. If a child's attendance continues to be a concern, we may get in touch to see if we can offer support to help it improve.

Secondly, North Yorkshire Council's Code of Conduct For The Use of Penalty Notices states that in the case of unauthorised leave of absence (Holiday) taken in term time, school will contact the Local Authority to request the issue of a Penalty Notice, if there have been at least 10 sessions (5 days – each session is half a day) of unauthorised absence in the preceding four months. In relation to children in Reception, this would come into force after the date that the child must start full-time education: This is on 31 December, 31 March or 31 August following their fifth birthday - whichever comes first. If your child's fifth birthday is on one of those dates then they reach compulsory school age on that date. If you feel that you have been issued with a penalty notice incorrectly, please let us know.

What the law says...

As a parent, ensuring your child attends school **regularly and on time** is your **legal responsibility**. You must make sure your child gets a full-time education that meets their needs (for example if they have special educational needs). You can send your child to school or educate them yourself.



What the government says...

Government guidelines state that attendance of less than 90% is classed as 'persistent absence'.

The government expects that in order to reach a child's full potential, they must attend school for a minimum of 95% of the year.

At Lindhead, we will regularly inform you of your child's attendance rates. Please see inside this leaflet for details.

A Summary of our Attendance Policy



- Children are welcome to arrive on site from **8.35** each morning. Staff are always on hand after this time.
- Children are expected to be in their classrooms and ready to start their day at **8.45am**, after which time gates are locked. Children will need to report to the school office if they are late.
- Parents are expected to inform the school office by **8.50am** each day a child is unwell and will not be attending school.
- North Yorkshire Council guidance will always be followed where a child's attendance causes concern. 'Early Intervention' letters will be sent if a child is at risk of becoming classed as a 'persistent absentee' (less than 90% attendance), and more formal procedures will follow if necessary.
- As a first response, parents will receive a letter encouraging better punctuality when a child has more than 6 late marks in a half-term.



Term-Time Leave of Absence

Under current regulations, head teachers may not grant leave of absence during term-time (for example, family holidays) unless there are exceptional circumstances. Family holidays will very rarely be considered as 'exceptional circumstances' and will be classed as unauthorised absence. Illness Guidance...

Being ill may prevent your child coming to school, but if they are up playing or gaming then they could be in school. Looking after your child is very important to us and we will of course contact you if we feel they should be at home.

If your child's attendance falls below 90% due to illness, we may ask that you provide medical evidence so that we can authorise the absence.

Did you know?

- If your child attends school between 95% and 100% of the time, they have the best chance to achieve their potential, educationally and socially.
- Whilst 90% attendance might sound good....
 - 90% = 1/2 day off each week per year
 - 90% = 1 month off school per year
 - 90% = 1 whole school year during a child's education career
- Children with low attendance can struggle with friendships as well as struggling to keep up with school work.

Please do not be offended if we get in touch with you about your child's attendance; all schools are obliged by law to promote good attendance and punctuality.

Health Through Warmth Project

North Yorkshire Council are reaching out to advise that funding is available to help vulnerable residents with the cost of gas repairs and servicing. This funding must be allocated by the end of February as the scheme finishes end of March so please apply as soon as you can if you think you are eligible.

The funding is available to Homeowners who meet certain income thresholds AND have a relevant health condition as shown below.
